ACCEPTABLE USE POLICY FOR TECHNOLOGY Crivitz Youth, Inc. Teen Center

The technology available at the Crivitz Youth, Inc. Teen Center—including computers, smart TV, gaming systems, and Wi-Fi—is provided for the use and enjoyment of student members. By using this technology, members agree to comply with the following Acceptable Use Policy.

- Privacy: Material viewed, created, or stored on Teen Center technology is not guaranteed to be private. Teen Center staff may monitor use at any time to ensure compliance.
- Content Restrictions: The Teen Center's Wi-Fi is filtered to block access to inappropriate websites. Students may not attempt to bypass these restrictions. Students may not use personal devices (even on personal data plans) to view, access, or share inappropriate content while on Teen Center property. Doing so will result in disciplinary action.
- Consequences: Any student found attempting to access or share offensive, inappropriate, or illegal content will face disciplinary action. Consequences may include loss of technology privileges, suspension or expulsion from the Teen Center, and/or referral to law enforcement depending on the seriousness of the violation.

The following are strictly prohibited:

- 1. Damaging or interfering with Teen Center technology, hardware, or software.
- 2. Sharing or posting personal information such as addresses, phone numbers, or private account details.
- 3. Viewing, transmitting, or receiving obscene, pornographic, violent, or otherwise objectionable material.
- 4. Bullying, harassing, or threatening others through any form of technology.
- 5. Using Teen Center technology for business, financial gain, gambling, or illegal activity.
- 6. Creating, spreading, or attempting to introduce viruses or malicious software.
- 7. Violating any local, state, or federal laws or regulations.
- 8. Taking photos or videos of other members or staff without their permission.
- 9. Posting or sharing content created at the Teen Center on social media in a way that is harassing, threatening, or otherwise inappropriate.
- 10. Bringing food or drinks near computers, gaming systems, or smart TV.

Use of Crivitz Youth, Inc. Teen Center technology is a privilege, not a right. All members are expected to use technology responsibly and respectfully.
