- Possessing, using, or being involved with drugs, alcohol, tobacco (including chewing, smoking, or vaping), or weapons. These items are strictly prohibited on CYI property.
- Damaging, defacing, or stealing property belonging to CYI or others.
- Engaging in inappropriate physical or verbal contact.
- Running, pushing, fighting, littering, or throwing objects outside of supervised activities.
- Making loud, rude, or disruptive noises.

Possible Consequences; If a participant engages in unacceptable behavior, one or more of the following actions may occur:

- Meeting with staff to discuss the behavior.
- Meeting with staff and the participant's parent or legal guardian.
- Restriction from the Teen Center if behavior continues or if a parent/guardian will not meet.
- Suspension or expulsion from the Teen Center.
- Requirement to pay for damages (restitution).
- Notification of law enforcement.

Internet access means access to computers and people all over the world and makes material available that may not be considered appropriate for students. Any student found searching for a site which is deemed offensive will receive disciplinary action. Depending on the offense, the consequences may include loss of technology use privileges, disciplinary action up to and including suspension or expulsion from the center and/or criminal complaint.
